

**THORNBURY TOWNSHIP, CHESTER COUNTY  
BOARD OF SUPERVISORS  
REGULAR MEETING  
MINUTES – August 18, 2015**

**Bob Anthony motioned to approve the July 21, 2015 Board of Supervisors Meeting Minutes and the August 4, 2015 Work Session Meeting Minutes as presented. The motion was seconded by Bill Reilly. All were in favor. Motion carried.**

**AGENDA BUSINESS:**

*Penn DOT Winter Maintenance Agreement*

**Bob Anthony motioned to have the Township Manager send written notification to Alice Cosgrove of Penn DOT indicating that Thornbury Township is terminating its agreement of winter maintenance of Westtown Thornton Road. Westtown Thornton Road is a state road. All maintenance and repairs will be performed by Penn DOT. The motion was seconded by Mike Gallagher. All were in favor. Motion carried.**

*2015 Road Program Update*
