

**THORNBURY TOWNSHIP, CHESTER COUNTY
BOARD OF SUPERVISORS
REGULAR MEETING
MINUTES – July 19, 2016**

CALL TO ORDER:

The regularly scheduled meeting of the Thornbury Township Board of Supervisors was called to order by Bob Anthony at 7:00 P.M. in the Thornbury Township meeting room. In attendance were Supervisors Robert Anthony, Chairman; Jim Benoit, Vice-Chairman, Bill Reilly and Joe Lisa. Kathy Labrum, Solicitor; Judy Lizza, Manager; and Teresa DeStefano, Township Administrator, were also in attendance. The pledge of Allegiance was conducted by Bob Anthony.

APPROVAL OF MINUTES:

Bob Anthony motioned to approve the June 21, 2016 Board of Supervisors Meeting Minutes. The motion was seconded by Jim Benoit. All were in favor. Motion carried.

PUBLIC COMMENTS:

- Chris Kirby expresses concern for the removal of the speed humps on South Concord road and would like the Board to reconsider replacing them.
- Chief Bernot presented a plan for traffic enforcement; South Concord Road will receive 15-20 hours per month. Speed enforcement has been started since the enforcement lines are now painted on the street.
- Jim Jordan expressed his concerns and also gave some input on the history of the installing of the speed bumps on South Concord Road. He also would like to help the Board with any information he could give them that would be helpful with moving forward in this matter. Jim Jordan also offered his driveway for WEGO police to use for speed enforcement.
- Ann Connelly expressed her concerns with the removal of the speed humps and speeding on S. Concord Road. Paul Kittle provided his observations about vehicles not heeding the stop sign posted and at what times he feels it takes place most (non-rush hours). Chief Bernot appreciated his observations and would take the information back to the traffic team. He also offered his driveway for police enforcement of S. Concord Road. Mr. Kittle also felt that the speed humps deteriorated due to water accumulating near them and going through series of frost/freeze cycles.
- Molly Morrison requested that the Board reevaluate the traffic calming for S. Concord Rd.
- Michael Connelly feels that the speed has increased on the road and that safety issues will increase as well. He stated that he expects the volume to increase and requests the Board to reconsider replacement.
- Percy Neall discussed the Comprehensive Plan and the road classifications.
- Stan Horwitz stated he was in favor of the speed humps being removed.
- Chickie Horwitz thanked the Board for the paving project of Woodbine Road.
- Tim Dugan and Dorothy Dugan offered their driveway for the WEGO police to use for speed enforcement.

Judy Lizza gave a brief summary of the report. A copy of the complete manager's report is on file for your review.

UNFINISHED BUSINESS:


There was none.
