REGULAR MEETING  
MINUTES October 18, 2016**

**APPROVAL OF MINUTES:**

**Bob Anthony motioned to approve the September 20, 2016 Board of Supervisors Meeting Minutes, and also the October 4, 2016 Work Session Minutes. The motion was seconded by Jim Benoit. All were in favor. Motion carried.**

Historic Preservation Commission Comments for the Rokeby Farms Historic Resource Study submitted by Megill


