

RESOLUTION 2014-1

A RESOLUTION OF THORNBURY TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA APPROVING THE PAYMENT OF ROUTINE, RECURRING OBLIGATIONS

IT IS HEREBY RESOLVED THAT the Board of Supervisors of Thornbury Township, Chester County, Pennsylvania, hereby approves payment of all contracted and agreed upon rate payments for the year 2014. The Board authorizes the Township Manager and Treasurer to be responsible for the timely payment of these obligations and, in the absence of either, one (1) other Supervisor's signature will be required. The routine, recurring obligations included in this authorization are as follows:

Salaries and Wages:

Township Manager/Secretary - \$2,942 Bi-weekly, 3% Pension Match – Simple IRA
Assistant Treasurer/Deputy Tax Collector/Bookkeeper/Permit Officer, Address & Tenant Coordinator - \$2,401 Bi-weekly, 3% Pension Match - Simple IRA
Assistant Township Secretary, Subdivision & Land Development Coordinator, Zoning Hearing Board Coordinator, Office Administrator - \$19.89 Hourly, 3% Pension Match – Simple IRA

Payroll Costs:

USA Tax Payment - Federal Withholding Tax, Social Security at 6.2% and Medicare at 1.45%
PA Dept. of Revenue - State Withholding Tax – 3.07 % of gross
Keystone Collection Group - 1% Local Income Tax Withheld, LST (\$1.00 weekly)
PSATS Group Trust – 1.0% of first \$8,750.00 income of all employees, Unemployment Compensation
PA Unemployment Compensation - 0.07%

Chester Water Authority- Fire Hydrants
Comcast – Internet and telephone for Township Building
PECO – Electricity for Township Building, Traffic Signals, Town Center, Goose Creek Park


Tax & Assessment Collector Fees:


Property Taxes – 0.2% of gross taxes collected, 0.8% of gross taxes collected to Township

Keystone Collections Group - 1.35% of Current Taxes Paid: 1.35% of Delinquent Taxes


Transfer of Funds:


Transfer of funds from one account to another. Authorizing Township Manager and Assistant Treasurer to make investments at banks paying the best rate of interest and with the best terms.




