GRADING/STORMWATER PERMIT APPLICATION REQUIREMENTS:

Impervious Surface: Impervious surface is defined as a surface that has been compacted or covered with material to the extent that it is highly resistant to infiltration by water, including, but not limited to, roofs, sidewalks, patios, decks, sheds, driveways, tennis courts and swimming pools and the like.

Escrow Agreement: An Escrow Agreement is required for any Grading/Stormwater Management Permit Application that includes 500 sq. ft. or more of earth disturbance or impervious surface coverage area. In addition, the escrow funds must be provided to the Township prior to any Grading/Stormwater Management Permit being issued.

For a project with earth disturbance or impervious surface coverage area of 500 sq. ft., but under 2,000 sq. ft., the escrow amount required is \$300. If the escrow fund drops below \$100 at any time the contractor/property owner(s) must replenish the escrow back to the original amount of \$300 before work may continue.

For a project with earth disturbance or impervious surface coverage area of 2,000 sq. ft. and over the escrow amount required is \$1,000. If the escrow fund drops below \$300 at any time the contractor/property owner must replenish the escrow back to the original amount of \$1,000 before work may continue.

Exemptions: For exemptions and project requirements see *Thornbury Township Code, Stormwater Management Ordinance 2014-02 §116, A-D*.

Operation, Maintenance & Inspection Plan Agreement: All Grading/Stormwater Management Permit Applications with 500 sq. ft. and over of earth disturbance or impervious surface coverage require an *Operation, Maintenance & Inspection Plan Agreement* be executed and provided to the Township. See, *Thornbury Township Code, Stormwater Management Ordinance 2014-02, Appendix A.2*. The Operation, Maintenance & Inspection Plan Agreement form may be found on our website under permits.

Owner's Authorization: A fully executed Owner's Authorization form must accompany the Grading/Stormwater Management Permit Application if the applicant(s) are not the property owner(s). The Owner's Authorization form can be found on our website.

Plan Submission: Plans must be submitted if your project is 500 sq. ft. and over of earth disturbance or impervious surface coverage area.

For a project with earth disturbance or impervious surface coverage area of 500 sq. ft., but under 2,000 sq. ft., please see the *Simplified Approach to Stormwater Management for Small Projects, Thornbury Township Code, Stormwater Management Ordinance 2014-02, Appendix A.1.*

For projects over 2,000 sq. ft. two (2) sets of **engineered signed and sealed plans** must be submitted along with your Grading/Stormwater Management Permit Application. If plans with these specifications are provided your application will be rejected.

Please note that for projects over 43,000 sq. ft. of earth disturbance or impervious surface coverage area, in addition to the required two (2) sets of engineered signed and sealed plans, applicant(s) must also submit a signed and sealed “as built” plan upon project completion.

ACKNOWLEDGEMENT:

All Grading/Stormwater Management Permits are subject to applicable fees, payable at the time of application.
